REMARKS

1. Report from the Working Group, report from UOM
The work of WG started in April 2021. First meeting was held on 7. 7. 2021. Next meeting will be in October 2021.
2. Purchase of equipment, report from UOM
Tender was conducted during summer 2021, without any problems, in two separate calls, for small and big pieces of equipment. UOM is currently waiting for the delivery of large pieces of equipment.
3. Organization of next study visits
The proposal is to organize study visits to Serbia and Austria in mid-February and March 2022.
4. Activity 1.1 Review of best practices and experiences in DHE (ACADEMIA)
Academia will deliver the report by the end of October 2021.
5. Activity 6.1 Dissemination and exploitation plan (UOM)
Website is active, but the plan is not finished yet. The new deadline is the end of October 2021. In the plan the recommendations from NEO should be added.
6. Report from monitoring visit on June 30th 2021.
The coordinator informed the partners about the NEO report from the study visit.
7. Disciplinary diversity
Since this was the recommendation from NEO, consortium will continue working on the diversity of dual education across different study fields.
8. Dissemination activities inside UOM and towards other HEIs in Montenegro.

Magdalena Djuraskovic and Nemanja Djurisc. UOM will deliver extended information about Erasmus info day at UOM, in order to distribute the news on the website and in social media.

The representatives of the Ministry of Education, Culture and Sports were present at the SC meeting and during the study visit in Slovenia. The consortium will continue to improve the cooperation with the Ministry.
