# DISCUSSION FORUM ON THE PROPOSED DUALMON MODEL WITH KEY STAKEHOLDERS AND POLICY MAKERS

The members of the working group, who are in charge of developing the generic model of higher dual education, held a meeting in the premises of the Faculty of Economics on Wednesday, 8th December 2021. at 12:00 p.m. The subject of the meeting was a discussion on the draft proposal for the development of the generic model of higher dual education, as well as on the comments received from representatives of partner institutions. On that occasion, the effort that has been made so far in order to create a generic model was emphasized, and useful guidelines were given for its further improvement. With this regard, the conclusion is that in the next period special attention should be paid to the regulation of the legal framework for the implementation of higher dual education. Also, several recommendations were given with the aim to further clarify several potential doubts within the draft proposal of the model, in order to prepare the final version of the document. In the appendices given below can be found all comments given by Agency for Control and Quality Assurance of Higher Education and several companies (like Voli trade and Crnogorski Telekom), as well as responses of the project coordinator – prof. Savić, on the given comments.

Based on the comments on generic model of dual education obtained from partner institutions, the improved version of the generic model was developed and it was presented to the partners at the meeting held at Fauclty of Economics on 17th and 18th of December, 2021. On that occasion, with the presence of representatives of all partners within the DUALMON project consortium, a meeting of the Local Board was held. During the first working day, the subject of discussion was the proposed second draft of the generic model of dual education, as well as the activities based on the proposed model needs to be undertaken, and refer to the pilot testing of the given model and the development of specific models. In this regard, the dynamics of the realization of key activities within this work package are planned. In addition, significant attention was devoted to the discussion of the realized activities related to the internal and external dissemination of project results, as well as the ways of collecting information as a kind of metrics, i.e. indicators on the success of the project. During the second working day, the main topics of the meeting were related to the financial aspect of reporting on the activities implemented within the project and the preparation of formal reports. Also, on this occasion, the future efforts that need to be invested in terms of internal dissemination of the results were discussed, and a plan for further activities in this domain was devised.

Besides of the previously mention meetings, the importance of the DUALMON project was also presented at the cluster meeting with the National Erasmus+ Office. Namely, in mid-April, a cluster meeting was held between representatives of the National Erasmus+ Office, the Ministry of Education and working groups in charge of implementing four structural projects that are initiated at the University of Montenegro, which are related to dual education, reform of doctoral






studies, internationalization and strengthening the autonomy of University. The aim of this meeting was to review the progress made so far in the implementation of these projects, and potential barriers that may arise in the process, considering the significance that structural project have on the overall quality of higher education in Montenegro.

On this occasion, DUALMON was presented, as one of the four structural projects that is of great importance not only for the faculty units involved in its implementation, but also for the reform of the entire higher education. During the meeting, the project representatives presented the results of the efforts made so far in the implementation of the DUALMON project, with special emphasis placed on the adopted generic model of dual education, and developed specific models tailored to the needs of individual faculty units and their students. During the discussion, main outcomes of these activities were recognized, as well as potential barriers that may arise in the forthcoming period, and suggestions on how to overcome potential obstacles were given. Additionally, special attention was paid to the development of the legal framework and its harmonization, taking into account the specificities and main goals of dual education. This meeting was recognized as an important way of promoting the importance of DUALMON and other structural project, but also a good way for fostering other faculty units (and potentially other higher education institutions) that are not included in this project to consider the possibilities of adoption dual education program in the future. # Comments of the ACQAHE and the companies

#### Komentari na predlog dokumenta za razvoj generičkog modela dualnog obrazovanja - ACQAHE

U Srbiji, u predlogu generičkog modela, prema dokumentu https://dualedu.ef.uns.ac.rs/index.php/download/send/3-activities/131-development-of-the-generic-and-flexible-model-of-dhe-for-serbia lijepo je dat prikaz svih modela, njihovih prednosti i mana. <u>Kada je sve ostalo već korišćeno iz istog dokumenta, predlažemo da se doda i taj pregledni dio.</u>

Nedostaju primjeri za dva fakulteta koji su partneri na projektu i gdje bi se, takođe, trebao implementirati ovaj projekat. Dokument, prije usvajanja treba ponovo poslati i ostaviti dovoljno vremena partnerima da daju svoje mišljenje.

#### Takođe, ostaje nejasno:

- Da li će se pilot projekat realizovati na akademskim ili primijenjenim studijama? Objasniti izbor, i dati uporednu praksu zašto su se fakulteti odlučili baš za taj model! Prilikom akreditacije studijskih programa jedan od standarda koji se ocjenjuju je i uporedivost (<u>Standard 6. Uporedni primieri</u> dobre prakse / kriterijum 6.1 – Primjeri uporedivih implementiranih studijskih programa na drugim ustanovama visokog obrazovanja) – upravo nam ovdje to nedostaje... uporedivost izabranog/predloženog studijskog programa po predloženom modelu sa istim ili sličnim studijskim programima u regionu. Naravno, ne zanemarujemo činjenicu da će morati da se razviju i dodatni standardi za evaluaciju ovakvog modela studija.
- Da li postoji razlika između akademskih i primijenjenih studija?
- Detaljnije obrazložiti prednosti i nedostatke ovog modela studija na predloženim fakultetima na kojima će se izvoditi pilot projekat.
- Procentualno, koliko se vremena troši na predavanja koliko na praksu?
- Objasniti kako bi studenti polagali ispite/kolokvijume?
- Koja institucija će vršiti provjeru i kako će se vršiti provjera da li student zaista radi u pomenutim komanijama?
- Kako će se izvršiti evaluacija studenata? Da li će ulaziti u sklopu ocjene na fakultetu koja im se formira u smislu da će taj praktični rad nositi određeni broj poena?
- Na koji način će se uskladiti komunikacija profesora sa fakulteta i mentora u kompanijama?
- Na koji način će biti organizovan ispitni rok za dualne studente? Da li će nastava dualnih studenata biti usklađena u smislu da imaju poseban raspored u odnosu na druge studente? To je važno zbog samog praćenja nastave dualnih studenata i njihove prakse.
- Prikazani su kalendari, i objašenjeno je kroz ove tabele kako bi to trebalo da izgleda (koliko može da se shvati) ali pokušati da se na jednoj strani, kroz dijagram, prikažu ključne aktivnosti (koje se odnose i na prijavu studenata – kada se oni prijavljuju za dualni model studija, ako se prijavljuju na početku, prilikom upisa, da li to znači da će svi obaviti praksu u nekoj kompaniji, ako se prijavljuju kasnije, kada je to i sl.). Da li će se razlikovati upis studija i status studenata koji studiraju po dualnom modelu u odnosu na tradicionalni
