## <u>REMARKS</u>

- 1. Activity 6.4 Final conference Prof. Melovic introduced the partners about the organization of the conference. The members of the consortium have a clear understanding of the main goal of the conference, and it is in line with the description in the project proposal.
- 2. WP3: 3.1 Amendments to the law on higher education and creating of draft law on dual education, update by the University of Montenegro Representative of the Ministry of Education, Ms Ćetković, will be present at the conference. Since the ministry has a completely new staff, the consortium will introduce Ms Ćetković with the significance of the project and dual education as a whole, with the final goal to implement dual higher education into the proposal of the new Law on higher education.
